Reasons for **expulsion**:

- The use and consumption of tobacco, alcohol or any other drugs during the length of the Programme.
- Leaving the camp ground without proper authorization by the AFS Camp Monitor.
- Any behaviour considered aggressive toward other Programme participants and Staff.
- Theft of other's belongings during the Programme.

Reasons for a **First Warning** that may lead to expulsion:

- Lack of respect toward other Participants and Staff members of the Programme.
- Infringement of Programme rules.
- Purposeful damage to property, materials or natural environs.
- Use of private and/or public phones outside of the established times.

Camp monitors always encourage participants to take part in all activities. In the case that a participant chooses not to participate in an activity they may do so however, they must remain with the group throughout the activity.
